









## Fig.6 Collector-Emitter Saturation Voltage vs. Collector Current (II)







# Fig.7 Base-Emitter Saturation Voltage vs. Collector Current




## Fig.8 Gain Bandwidth Product vs. **Emitter Current**




Fig.10 Safe Operating Area





Fig.11 Safe Operating Area
