



Relative Intensity Vs. CIE Wavelength










LED is recommended for reflow soldering and soldering profile is shown below.


Reflow Soldering Profile for SMD Products (Pb-Free Components)




- 1. All temperatures refer to the center of the package, measured on the package body surface facing up during reflow.

❖ The device has a single mounting surface. The device must be mounted according to the specifications.






- 1. Wavelength: +/-1nm

- 3. Forward Voltage: +/-0.1V




