#### LED is recommended for reflow soldering and soldering profile is shown below.




1. All temperatures refer to the center of the package,


- measured on the package body surface facing up during reflow.

  Maximum number of soldering passes: 2




# **Recommended Soldering Pattern (Units : mm; Tolerance: ±0.15)**

#### Remarks:

1. Wavelength: +/-1nm


2. Luminous intensity / luminous flux: +/-15%

3. Forward Voltage: +/-0.1V

Note: Accuracy may depend on the sorting parameters.
