









Relative Intensity Vs. CIE Wavelength








LED is recommended for reflow soldering and soldering profile is shown below.

Reflow Soldering Profile for SMD Products (Pb-Free Components)




- 1. All temperatures refer to the center of the package,

 2. Do not apply any stress to the LED during high temperature conditions.




♦ Recommended Soldering Pattern (Units: mm; Tolerance: ±0.15)




- 1. Wavelength: +/-1nm
- 2. Luminous intensity / luminous flux: +/-15%
- 3. Forward Voltage: +/-0.1V

Note: Accuracy may depend on the sorting parameters.
